KEYNOTE SPEAKER

Margarita Alegría, PhD

Dr. Alegría is director of the Center for Multicultural Mental Health Research (CMMHR) at Cambridge Health Alliance. She oversees an interdisciplinary group of professionals that assist in the research, analysis, and administration of the Center projects. Dr. Alegría worked for 22 years at the University of Puerto Rico, most recently as director of the Center for Evaluation and Sociomedical Research (CESR) and as a professor. She was awarded the 2003 Mental Health Section Award at the 131st Meeting of the American Public Health Association. Dr. Alegría has devoted her professional career to researching disparities in mental health and substance abuse services for Latinos and other minority populations. Her published work focuses on defining and proposing solutions to disparities in mental health care services in minority populations, specifically Latinos in Puerto Rico and the United States; conceptual and methodological issues with minority populations; risk behaviors; and disparities in service delivery. Dr. Alegría serves on the board of directors for the Children's Foundation and the Felisa Rincón De Gautier Foundation. She earned a bachelor's degree from Georgetown University, a master's degree from the University of Puerto Rico, and a Ph.D. from Temple University, all in psychology.

Honorable Carmen L. Lopez

A native of Puerto Rico, the Honorable Carmen L. Lopez is currently serving her second eight-year term as a judge of the Connecticut Superior Court, having been appointed to the position in 1996. Judge Lopez has had a long-standing involvement with Latino organizations in Bridgeport, as well as those representing the Latino community on a state-wide level. She is listed in Who's Who Among Hispanic Americans. A Business Administration graduate of Sacred Heart University, Judge Lopez received her J.D. from Suffolk University Law School and is a member of the Connecticut, Bridgeport and Hispanic Bar Associations. Judge Lopez is married to Judge Dale W. Radcliffe, who also serves on the Connecticut Superior Court. Judge Lopez is currently assigned to the Civil Division of the New Haven Judicial District. Judge Lopez's

tenure on the Superior Court has been marked by leadership of initiatives aimed at enhancing the judicial system's ability to address and prevent problems affecting families and youth. Judge Lopez also coordinated the Connecticut judicial system's participation in a federal program designed to improve its ability to serve court-involved girls and young women. Her commitment to using the judicial system to address the needs of children and youth provided the impetus for her to organize the 2000 Juvenile Court Law Day event, which brought together numerous community and national lead-
