

## **Center Scores Important Legislative Wins!**

Public Act 16-147 implements recommendations of the state legislature's Juvenile Justice Policy Oversight Committee, which include closing the Connecticut Juvenile Training School and Pueblo, limiting criteria for entry into detention, and enhancing educational supports for youth. The Center for Children's Advocacy's Students First Report formed the basis for the educational provisions of this legislation. Public Act 16-123 ensures that the voices of youth in DCF care are heard, requiring youth advisory councils at congregate care facilities, providing foster care family profiles for foster children and soliciting feedback from foster children to help recruit, train and retain high-quality foster parents. Public Act 16-188 directs schools to **post DCF Careline information to help children suffering from sexual and physical abuse**. In Connecticut, over 7500 children are victims of abuse or neglect each year. Posted information will include assistance that is available and how to access it. Special Act 16-8 As the current NEMT vendor, Logisticare failed to meet performance standards outlined in its contract. This legislation addresses overwhelming problems with service, requires the new contract to be the result of competitive bid, and **ensures that patients receive adequate transportation that fulfills their medical needs**. Over 150 children will have their utilities protected as a result of the Center's recent Keep the Power On clinics.

Families facing utility termination were served by clinics at Connecticut Children's Medical Center, Yale New Haven Hospital and The Hospital of Central Connecticut. Pro Bono volunteers from Aetna's Legal Department, Pullman & Comley, Murtha Culina, and UConn and Yale Law Schools were trained by CCA attorneys to provide counseling and support for participating families.



Community Resource Team of Hartford, Community Action Agency of New Haven, Human Resources Agency of New Britain, Operation Fuel, 211 INFOLINE, Food Share, Center for Care Coordination at Connecticut Children's Medical Center and Lulac Head Start were on site to
