

# An affordable housing crisis: rental costs are out of reach




Hours needed at minimum wage to afford a one-bedroom unit

60 hours per week or less 61 to 78 hours per week 79 hours per week or more



#### Eviction filings in CT, 2017-22


If evictions are filed at the same rate through the rest of March, Connecticut will see the highest number of filings in a month since at least 2017. Hover over the line to see the number of filings by month.

The COVID-19 pandemic has put an increasing number of people at risk for eviction, which is associated with many adverse health outcomes and contributes to health inequities.


Emergency and long-term interventions are needed to address this public health crisis.

# The eviction crisis is also a legal issue...



## Why Right to Counsel

- Unrepresented tenants nearly twice as likely to experience a removal order.
- Only 7% of tenants who appear in court have representation compared to more than 80% of landlords.
- White tenants more likely to have representation than tenants of color.

## Where Right to Counsel

- 8 cities and counting since 2017
- In 2021: CT, MD, WA

# How Did We Win Right to Counsel in CT?

### **Connecticut Right to Counsel Coalition**

- Lead by the Central CT DSA in partnership with over 40 different organizations
- In 7 months, coalition and allies successfully advocated for the passage of a statewide bill with \$20 million of federal ARPA funds for the first two years

### Key campaign elements

- RTC petition and coalition building
- Educational materials & information sessions
- Phone banks
- Public hearing testimony guide & workshops
- Op-eds written by a diverse set of coalition members
- Letter from 125 medical professionals urging Gov. Lamont to use federal relief funds for Right to Counsel































































# Implementing a Right to Counsel for Tenants

- Connecticut is just the second state to implement Right to Counsel!
- Rolling out across the state as attorneys are hired and trained
- Currently open to tenants in 15 zip codes and all U.S. military veterans statewide



# How to Access Right to Counsel

- Tenants receive a notice about the Right to Counsel program with the Notice to Quit and the Court Summons
- Tenants can call 1-800-559-1565 to request an attorney
